**THE UNIVERSITY COURT OF THE UNIVERSITY OF ST ANDREWS ("ST ANDREWS")  
 INSTITUTO DE INVESTIGACIONES DE LA AMAZONÍA PERUANA (THE "IIAP")  
 ACADEMIC COLLABORATION AGREEMENT DATED 21 FEBRUARY 2018 BETWEEN ST ANDREWS  
 AND THE IIAP ("THE AGREEMENT")**

We refer to the Agreement between the above noted parties.

All words, phrases and terms used in this letter shall have the meanings given to them in the Agreement, except where they are defined in this letter. The term "herein" and words of similar import refer to this letter.

Except as expressly provided for in this letter, the Agreement will remain unchanged and in full force and effect.

Where any issue arises in relation to this letter, which is not expressly addressed in this letter, then the provisions relating to that issue in the Agreement shall also be applied to this letter.

**VARIATIONS**

In order to clarify, supplement and amend the terms of the Agreement with effect from the date of acceptance of the terms of this letter by the IIAP, the Parties have agreed that Schedule 3 of the Agreement be and is amended as follows:-

(a) the table shall be deleted and replaced with the following:

(iii) on or after 1 January 2019 but by no later than 15 December 2020, for up to US \$7,729.50, being the balance of actual expenditure incurred during the Project (and not accounted for in the Initial Payment and the Second Payment)".

In the event of any conflict between the terms of the Agreement and the terms of this letter, the terms of this letter shall prevail.

This letter and any disputes or claims arising out of or in connection with its subject matter are governed by and shall be construed in accordance with the law of England and the parties irrevocably agree that the courts of England shall have non-exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this letter.


The Parties may prepare a Spanish-language translation (or a translation into any other language) of this letter agreement for administrative purposes. However the Parties agree that the English-language version of this letter agreement shall take precedence over any such translation in the event of any dispute between the terms of such documents.

This letter agreement may be executed in any number of counterparts, each of which when executed (and delivered) will constitute an original of this letter agreement, but all counterparts will together constitute the same agreement. No counterpart will be effective until each party has executed at least one counterpart.


